In support of strengthening student academic achievement, A.S. ### **Section A: JOINTLY DEVELOPED**

**A.S. Jenks** will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

*In the Spring of 2018, parents were encouraged to attend a meeting in which they could review and give input into this document, as well as the Compact. Parents were notified of this meeting through flyers and monthly calendars sent home with students as well as a phone blast. This parent input meeting was held this year on May 31, 2018.*

We will also provide and send home a copy of the Parent and Family Engagement Policy at that time. Parents will be notified by flyer, monthly calendar and school messenger.*

Parents are notified about various meetings, assemblies and events during the school year through flyers and monthly calendars sent home with students as well as through a phone blast. Meetings, trainings and workshops are held at various times of the day to accommodate all families and their schedules. All communications sent home are in the family home language. Any translation can be made available upon request from the district office of translation services.*

*Each Spring, parents are encouraged to attend a budget review meeting. At this time, parents can give input into how they would like to see the parent involvement funds to be spent. Materials and supplies will be given to parents to teach them how to support their children's reading and math skills at home as well as set routines conducive to positive achievement results. In addition, literature supporting these efforts will be purchased as well.*

#### **Section F: COORDINATION OF SERVICES**

**A.S. Jenks** will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children by:

*We have partnered with Modells and Chick-Fil-A as a way to fundraise for the school. On a particular day anyone who makes a purchase from these companies and states they are a Jenks family or community member, a portion of the proceeds are given to the school. The Eat Right Now program offers classes at school for students promoting healthy nutrition, and they attend Home and School Association meetings to show parents how to shop for healthy foods and make healthy recipes. Cooking demonstrations take place at the meetings. Also, at least five times a year, the Farm Stand is set up outside the school with health produce at a low price encouraging a healthy diet to support academic achievement.*

#### **Section G: BUILDING CAPACITY OF PARENTS**

**A.S. Jenks** will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

1. Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and
2. Materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement
3. Providing assistance to parents of participating children, as appropriate, in understanding topics such as the following:
  - a) The challenging State's academic standards
  - b) The State and local academic assessments including alternate assessments

- e) How to work with educators to improve the achievement of their child

*Various workshops and trainings are offered to parents throughout the school year. Some of the topics being covered are: Parent portal, science experiments with parents, getting ready for PSSA (literacy and math workshops). During the Annual Title I meeting, held each September, we share with parents the requirements of Title I, Part A, the State's academic standards and local academic assessments. There are three report card conferences throughout the school year, November, February and April, with an evening conference offered each time. During these conferences teachers will discuss with parents how to work with educators and monitor their child's progress.*

**Section H: BUILDING CAPACITY OF SCHOOL STAFF**

**A.S. Jenks** will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

*Surveys are made available to parents during all events, meetings and conferences. The results of the parent surveys are tallied and shared with staff during Professional developments throughout the school year. In August, staff will be trained on how to communicate and work with parents as equal partners.*

**A.S. Jenks** will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

*A.S. Jenks parents will attend a meeting regarding the School Improvement Plan and Federal Budget Addendum formulation meeting on May 1, 2019. Staff will ask for parent input during School Improvement Plan and Federal Budget Addendum implementation. Parents have access to the final School Improvement Plan to allow parents to monitor implementation of actions promised occurs.*
