To Each Member of the Graduating Class of 2020, Parents and/or Guardians:

Senior year will move quickly and we want each member of the senior class to graduate and participate in all activities. We are reminding students and their families about the guidelines for participating in graduation activities.

Students must meet the following criteria during their senior year:

1. Fulfill all graduation course work requirements.
2. Including the completion of
 - a. Naviance,
 - b. FAFSA
 - c. PHEAA
 - d. Senior Exit Survey
3. Complete all make up credits by May 30, 2020.
4. Maintain appropriate behavior. (Including academic honesty)
5. Maintain good attendance. (No truancy letters on file)
6. Arrive to school on time daily. (No referrals to the Attendance Designee)
7. Signed clearance sheet (does not owe money for books, equipment, uniforms, etc.).
8. Attend all scheduled graduation rehearsals and required senior meetings/activities.
9. Follow the SDP Student Code of Conduct
10. Submission of senior dues which are required to fund the senior activities.
(\$200.00 on or before December 1, 2019 and \$250.00 beginning
December 2, 2019-April 1, 2020.)
