Overview of the Quarterly School Manager Report

The Quarterly School Manager Report is a summary report on the finances and management of the School District of Philadelphia. It is prepared by the Office of Finance.

The purpose of the Quarterly School Manager Report is to provide senior management of the School District of Philadelphia with a summary of the District's progress in implementing the financial and management goals of the current fiscal year on both a "Year-to-date Actual" basis and on a "Forecast for Full Year" basis.

While the Quarterly School Manager Report focuses narrowly on the financial management of the District, it is important to keep in mind the real educational impacts to children and families of the District's financial status. Many schools lack a full array of resources and educational opportunities. Our financial plans are only effective to the extent that they provide for an adequate education of all public school children in Philadelphia.

The Quarterly School Manager Report contains the following reports and schedules:

Operating and Federal COVID-19 Relief Funds: The Quarterly School Manager Report presents a combined presentation of revenues and expenses for the principal operating funds, in addition to detailed revenue categories in the general, intermediate unit, and debt service funds; and expenditure and current budget information divided according to the District's functional hierarchy. Additionally, this report includes revenue and expenditures for Federal COVID-19 relief funds.

The principal operating funds of the District consist of a General Fund, Intermediate Unit (IU) Fund, and a Debt Service Fund. The District is required, as a result of its covenants to holders of fixed rate bonds of the School District, to deposit funds into its sinking funds during the current fiscal year to pay some of the debt service due in the next fiscal year.

For all quarters except the fourth quarter, the operating reports present quarterly year-to-date actuals for the current fiscal year and prior two fiscal years; the current full year projection and full year actuals or latest projection for the prior two years; and the year-to-date actuals as a percentage of the total year. The fourth quarter report presents the current year amended budget, current full year projection, the current year projected budget variance, and full year obligations for the prior two years.

Cash Flow: The Cash Flow section includes year-to-date cash flow and vendor payment information. The School District's adopted cash flow is based on the current fiscal year's adopted budget. The cash flow projections are updated to

reflect actual year-to-date results and changes to assumptions as to the timing of revenues and the payment of expense which are made as a result of actual events. The vendor payments report includes the cash payments made to date in the fiscal year to the District's vendors. The list contains payments inclusive of operating and grants expenditures.

Personnel Reports: The Position Summary Report contains budgeted and projected Full Time Equivalent positions and current On-Board actual employees. Budgeted and projected positions are derived from the Office of Management and Budget personnel projection system reconciled to the Staffing Management System for school-based positions. Current On-Board employees are taken from the District's Advantage HR Staffing system and include On-Board employees at months-end with status codes 1 (Active), 2 (Acting), 3 (Long-Term Substitutes), and other codes for certain employee groups. There may be instances when the Count (Filled column) is fractional which represents an employee in a part-time position. The Quarterly School Manager Report also includes a Vacancy Report which is a listing of teacher vacancies by school for operating and grant funds.

The Position Report and Vacancy Report may vary due to timing differences, different definitions of what constitutes a vacancy, and different definitions of when a vacancy is considered filled.

Supplementary Materials: This section of the Quarterly School Manager Report contains additional materials related to the operations of the School District.

The Debt Service Schedule is the District's current fiscal year projected operating debt service budget (net of refunding), which depicts each bond series outstanding broken down by principal and interest due in the current fiscal year. "Trapped funds¹" reserved or released in the current year are shown separately.

The Capital Projects reports include a listing of the District's activities related to capital projects, in addition to detailing the monthly year-to-date cash balances for all bond funds held to pay capital projects.

The documentation also includes information regarding the school allocation methodology, major grants funds and corresponding descriptions, school-by-school Title I budgets and spend, a summary of minority and women business enterprise participation, and a listing of the data posted on the District's website as part of the Open Data Initiative.

Introduction

Overview

The School District of Philadelphia's Quarterly School Manager Report for the period ended December 31, 2021 represents forward-looking statements and any such statements are subject to a variety of risks and uncertainties that could cause actual results to differ materially from those that have been projected. Please note that the FY21 actuals contained in this report are based on the District's current FY21 unaudited financial statements.

As of the end of the second quarter of FY22, the District projects operating and Federal Relief Act revenues and sources of \$4.035 billion and operating and Federal Relief Act expenditures and uses of \$3.896 billion, resulting in a surplus of \$139.6 million excluding changes in reserves, and a surplus of \$138.8 million including changes in reserves². The District is projected to end FY22 with a \$341.3 million positive ending fund balance.

This represents a \$57.4 million increase relative to the FY22 Adopted operating and Federal Relief Act ending fund balance of \$283.9 million.

Second Quarter Report Revised Projections

The District's currently projected year-end fund balance of \$341.3 million, as of December 31, 2021, represents a \$9.7 million increase from the September 30, 2021 projection and is due primarily to a (\$88.6) million reduction in projected expenditures, a (\$93.5) million reduction in projected revenues, and a \$14.5 million increase in the unaudited FY21 ending fund balance (i.e. the FY22 beginning fund balance). FY22 adjustments since the September projection include:

Revised FY22 projected revenues:

- \$1.8 million increase in Local Tax Revenue due to a \$1.7 million increase in Business Use and Occupancy Tax and a \$0.1 million increase in Rideshare Revenue;
- (\$1.0) million net reduction in Local Non Tax Revenue due to a (\$2.7) million reduction in revenue from the Philadelphia Parking Authority, partially offset by increases in Miscellaneous Non Tax and Gaming revenues;
- \$32.4 million net increase in State Revenue due to a \$22.8 million net increase in estimated Retirement and Social Security reimbursement from the State related to Operating Fund staffing costs, an \$8.4 million increase

in the Transportation Subsidy, and a net \$1.2 million increase in all other State revenues; and

 (\$126.8) million reduction in Federal COVID-19 Relief Revenue due to a shift in the timing of expenditures and associated reimbursement.

Revised FY22 projected expenditures

- (\$89.9) million net reduction in District Operated Schools expenditures, primarily due to shifts in the timing of federal relief fund spending and savings related to staffing challenges from the COVID-19 pandemic.
 Notable adjustments from the Q1 report include:
 - Reduction in Elementary Schools due to underspend related to additional extra-curricular federal funds provided to schools for before and after-school programs;
 - Shift of expenses from Learning Recovery, where funds were budgeted at Adoption prior to detailed spending plans for federal funds, to the areas where the actual expense is occurring, including Summer, Central Book Allotment, and Other Instructional Support;
 - Shift of expenses from Supplemental Facilities Investments, where funds were budgeted at Adoption prior to detailed spending plans for federal funds, to the areas where the actual expense is occuring, including Facilities Custodians and Building Engineers and Facilities Maintenance and Repair Services. Supplemental Facilities Investments are projected to be \$50.0 million, as of December 31, 2021, for anticipated spend related to a contract with Philadelphia Authority for Industrial Development (PAID) for the replacement of three school buildings;
 - Increase in Education Technology for additional expenses related to technology needs for schools and staff, including a laptop refresh for teachers and Smartboards; and
 - Reduction in hard to staff areas, including Nursing and Psychologists.
- (\$2.0) million reduction in Debt Service expenditures due to a bond closing and confirmation of final costs associated with that bond's interest payment;
- \$12.0 million increase in charter school tuition expenditures, due to the continued increase in cyber charter school enrollment, and a \$7.0 million increase in charter transportation;
- (\$5.4) million reduction in Education of Students Out of District due to reductions in projected spend for students in approved private schools and court ordered or behavioral health placements;
- (\$6.6) million net reduction in Administration expenditures, primarily due to:
 - Shift of expenses from Supplemental Social Emotional Supports, where funds were budgeted at Adoption prior to detailed spending

plans for federal funds, to the areas where the actual expense is occurring, including School Safety, Climate, and Culture and the Chief of Schools Office:

- Savings related to staffing challenges from the COVID-19 pandemic;
- An increase in the Chief Evaluation, Research, and Accountability for Universal Screener assessment related to the Board's Goals and Guardrails; and
- (\$3.6) million savings in Undistributed Budgetary Adjustments.

Year-to-date revenue variances are primarily driven by the following:

- FY22 year-to-date Local Tax revenue as compared to FY21 is \$34.1 million higher, primarily due to a combined \$36.9 million increase in Real Estate Tax, Liquor Sales Tax, Business Use and Occupancy Tax, Sales Tax, and Ridesharing Revenue, partially offset by a combined (\$2.8) million reduction in School Income Tax, Cigarette Tax, and Public Utility Realty Tax. FY21 year-to-date Local Tax revenue as compared to FY20 is (\$42.8) million lower due to a (\$43.4) million reduction in Real Estate Tax, Liquor Sales Tax, Business Use and Occupancy Tax, Cigarette Tax, Sales Tax, Ridesharing Revenue, and Payments in Lieu of Taxes collections, partially offset by a \$0.6 million increase in the School Income Tax and Public Utility Realty Tax collections;
- FY22 year-to-date Local Non Tax revenue in FY22 is (\$0.8) million lower than in FY21 due to a combined (\$3.0) million reduction primarily in Interest Earnings, Stadium Agreements, and Miscellaneous Non Tax Revenue, offset by a combined \$2.2 million increase in the City Grant, the Voluntary Contribution Program, and Gaming Revenue. Local Non-Tax year-to-date revenue in FY21 is

higher than in FY20 by \$14.8 million, primarily due to a \$18.6 million increase in the City grant, other Miscellaneous Non-Tax revenue, and Gaming Revenue collections, partially offset by a (\$3.8) million net decrease in collections associated with investments and Voluntary Contributions;

- FY22 year-to-date State revenue in FY22 is \$17.9 million higher than in FY21 due to a combined \$34.0 million increase in the Basic Education and Special Education subsidies, and Special Education Program revenue, offset by a combined (\$16.1) million reduction in the Vocational Education Subsidy, Transportation reimbursement, and PSERS and Social Security reimbursement. FY21 year-to-date State revenue in FY21 is \$3.8 million higher than in FY20 due to a \$10.0 million combined increase in PSERS and Social Security Reimbursement, the Special education Program, and increases in Vocational Education and Transportation Reimbursement, offset by a (\$6.2) million combined reduction in the Basic Education and Special Education subsidies and Special Education Transportation Reimbursement;
- FY22 year-to-date Federal revenues are relatively even with FY21 and FY20 year-to-date totals;
- Other Financing Sources year-to-date revenues vary each year due to the sale of property or debt financing. FY22 year-to-date collections are (\$17.8) million lower than FY21 due to the one-time premium associated with financing. FY21 year-to-date collections are \$13.9 million greater than FY20, related to the same premium noted for the District's short-term borrowing; and
- Federal Relief Funds revenue did not exist prior to FY21. As the Federal Relief Fund revenue associated with COVID-19 recovery is received on a reimbursement basis, no revenue was reflected by December 31, 2020 for FY21. \$108.8 million has been received through December 31, 2021 for FY22.

Expenditures – Year over Year

The following table shows a year over year comparison of second quarter year-to-date expenditures from FY20 to FY22.

Significant differences in year-to-date expenditures in FY22 compared with prior years include:

- A. Salaries Year-to-date salaries are \$40.6 million higher in FY22 compared to FY21 primarily due to increases in salaries and bonuses associated with new collective bargaining agreements. Year-to-date salaries are \$6.2 million higher in FY21 compared to FY20 primarily due to normal increases in staffing complement and compensation.
- B. Benefits Year-to-date benefits are \$62.0 million higher in FY22 compared to FY21 due to the above mentioned increases associated with new collective bargaining agreements and due to the timing of an accounting adjustment. Year-to-date benefits are comparable in FY21 relative to FY20.
- C. Non-Personnel Services (NPS) FY22 year-to-date NPS expenditures are \$44.4 million higher compared to FY21 due primarily to an increase in expenses related to COVID-19 as well as growth in charter expenditures due to increases in cyber charter school enrollment. Year-to-date NPS expenditures in FY21 are \$91.1 million higher compared to FY20 due to increases in cyber charter school enrollment, an increase in debt service expenses, and a reporting adjustment related to substitute services.

Prior Year Unaudited Actuals

Based on the District's unaudited actuals, the District projects operating revenues of \$3.465 billion and operating expenditures of \$3.435 billion in FY21, resulting in an operating surplus of \$30.2 million excluding transfers from reserves and \$29.4 million including transfers from reserves³. The District is projected to end FY21 with a \$202.5 million positive ending fund balance. This represents a \$68.1 million increase over the FY21 Amended operating and Federal Relief Act ending fund balance of \$134.4 million. The projected year end fund balance represents 5.9 percent of expenditures and other uses or less than four weeks of expense.

Issues and Risks

Since the end of the first quarter, the District completed agreements with all of its collective bargaining units and has continued to add additional support for students as they have returned to school, while continuing to reckon with pandemic challenges and continuing violence in the City.

Additionally, charter school expenditures continue to grow for two primary reasons: 1) continued increases in cyber charter enrollment and 2) reductions in prior year districtwide average daily membership (ADM), which is a key factor in the per pupil funding for charter students. The charter school tuition calculation is set by statute and generally represents the District's expenditures divided by the ADM from the prior year. As total ADM across all Philadelphia schools declined in the 2020-2021 school year,

expenditures did not decrease in proportionate amounts due to support needed for staff and students during the pandemic, which results in increased school tuition rates.

The Quarter 2 report reflects the half-year mark of the fiscal year and is a better depiction of the District's spending than the Quarter 1 report. The Quarter 3 report will refine these projections as we move further through the school year.

Conclusion

The current projections for FY22 reflect the District's best estimate of the impacts of COVID-19 and Federal Relief funding available to date. The District has improved the predictability for its largest expenditure - its workforce - for FY22 and the next few years with the successful negotiation of several labor agreements. At the same time, the challenges caused by the pandemic continue to create uncertainty as the District navigates staffing challenges, evolving protocols, and new supports for students and staff. While this creates a dynamic fiscal challenge for the School District, the significant additional Federal Relief funds allow the District to both navigate the impacts of the pandemic and manage a short-term period of investment. The District has created a framework for how it will approach spending these one-time funds to achieve both learning recovery and identify fiscally sustainable supports for the long-term. 
FY22 Adopted Operating and Federal Relief Fund Budget Summary

FY22 Adopted Budget


The District's budget consists of multiple funds: operating, categorical, capital, print, and food services. The adopted operating and Federal Relief Act budget includes a \$4.076 billion revenue budget and a \$3.926 billion expenditure budget.

Operating and Federal Relief Fund Revenues

District revenues are provided by the state, city, federal governments, and other sources.




Approximately 54.1 percent of local revenues are generated from real estate tax. The remaining 45.9 percent of local revenues come from other taxes and fees and a City grant. Approximately 70.0 percent of state revenues are provided through the basic education subsidy. The remaining 30.0 percent of State revenues come from other subsidies and reimbursements.





Operating and Federal Relief Fund Expenditures

The District's FY22 projected operating and Federal Relief Act budget includes operating and Federal Relief Act expenditures of \$3.926 billion. The District spends 87.4 percent of its budget directly on District, charter, and other non-District schools, with the remainder of the budget expended on debt service (8.6 percent) and District administration (3.9 percent).



Approximately 56.8 percent of the operating budget goes to District operated schools (including District administration). Of this amount, 52.9 percent goes to instruction, instructional support and other direct support to schools. The remaining 3.9 percent is budgeted for District administration.



The remaining 43.1 percent is budgeted for charter schools (31.6 percent), other non-District operated schools (2.9 percent), and debt service (8.6 percent).

A school's budget consists of school-based allocations and centrally-allocated resources. The school-based allocations include both operating and grant resources. The operating resources are allocated for administration, teachers (enrollment driven + prep), school support positions, and discretionary funds. Grant resources are provided by Title I and Title II, SIG, and other grants. The centrally-allocated resources include positions such as special education, nurses, ESOL teachers, facilities, and security.

The following outlines the allocation methodology used for the School Basic Operating Funds in FY 2022:
