# **Overview of the Quarterly School Manager Report**

The Quarterly School Manager Report is a summary report on the finances and management of the School District of Philadelphia. It is prepared by the Office of Finance.

The purpose of the Quarterly School Manager Report is to provide senior management of the School District of Philadelphia with a summary of the District's progress in implementing the financial and management goals of the current fiscal year on both a "Year-to-date Actual" basis and on a "Forecast for Full Year" basis.

While the Quarterly School Manager Report focuses narrowly on the financial management of the District, it is important to keep in mind the real educational impacts to children and families of the District's financial status. Many schools lack a full array of resources and educational opportunities. Our financial plans are only effective to the extent that they provide for an adequate education of all public school children in Philadelphia.

The Quarterly School Manager Report contains the following reports and schedules:

**Operating Funds:** The Quarterly School Manager Report presents a combined presentation of revenues and expenses for the principal operating funds, in addition to detailed revenue categories in the general, intermediate unit, and debt service funds; and expenditure and current budget information divided according to the District's functional hierarchy.

The principal operating funds of the District consist of a General Fund, Intermediate Unit (IU) Fund, and a Debt Service Fund. The District is required, as a result of its covenants to holders of fixed rate bonds of the School District, to deposit funds into its sinking funds during the current fiscal year to pay some of the debt service due in the next fiscal year.

For all quarters except the fourth quarter, the operating reports present quarterly year-to-date actuals for the current fiscal year and prior two fiscal years; the current full year projection and full year actuals or latest projection for the prior two years; and the year-to-date actuals as a percentage of the total year. The fourth quarter report presents the current year amended budget, current full year projection, the current year projected budget variance, and full year obligations for the prior two years.

**Cash Flow:** The Cash Flow section includes year-to-date cash flow and vendor payment information. The School District's adopted cash flow is based on the current fiscal year's adopted budget. The cash flow projections are updated to reflect actual year-to-date results and changes to assumptions as to the timing of revenues and the payment of expenses which are made as a result of actual events. The vendor payments report includes the cash payments made to date in the fiscal year to the District's vendors. The list contains payments inclusive of operating and grants expenditures.

**Personnel Reports:** The Position Summary Report contains budgeted and projected Full Time Equivalent positions and current On-Board actual employees. Budgeted and projected positions are derived from the Office of Management and Budget personnel projection system reconciled to the Staffing Management System for school-based positions. Current On-Board employees are taken from the District's Advantage HR Staffing system and include On-Board employees at months-end with status codes 1 (Active), 2 (Acting), 3 (Long-Term Substitutes), and other codes for certain employee groups. There may be instances when the Count (Filled column) is fractional which represents an employee in a part-time position. The Quarterly School Manager Report also includes a Vacancy Report which is a listing of teacher vacancies by school for operating and grant funds.

The Position Report and Vacancy Report may vary due to timing differences, different definitions of what constitutes a vacancy, and different definitions of when a vacancy is considered filled.

**Supplementary Materials:** This section of the Quarterly School Manager Report contains additional materials related to the operations of the School District.

The Debt Service Schedule is the District's current fiscal year projected operating debt service budget (net of refunding), which depicts each bond series outstanding broken down by principal and interest due in the current fiscal year. "Trapped funds<sup>1</sup>" reserved or released in the current year are shown separately.

The Capital Projects reports include a listing of the District's activities related to capital projects, in addition to detailing the monthly year-to-date cash balances for all bond funds held to pay capital projects.

The documentation also includes information regarding the school allocation methodology, major grants funds and corresponding descriptions, school-by-school Title I budgets and spend, a summary of minority and women business enterprise participation, and a listing of the data posted on the District's website as part of the Open Data Initiative.

<sup>&</sup>lt;sup>1</sup> In order to be compliant with Local Government Unit Debt Act (LGUDA) guidelines that all debt be amortized, bonds with a bullet maturity must have debt service payments set aside to pay the future principal and interest when it comes due as if there were an amortization schedule. Those funds that are set aside are considered trapped and are released when the payment is due.

## Introduction

## Overview

The School District of Philadelphia's Quarterly School Manager Report for the period ended June 30, 2022 represents forward-looking statements and any such statements are subject to a variety of risks and uncertainties that could cause actual results to differ materially from those that have been projected. Although the projections contained in this report are being released after the end of the fiscal year, this quarterly report is completed before the District's closing process is complete and before audited financial statements are prepared.

Please note that the information contained in this document includes revenue and expenditure detail inclusive of Federal COVID-19 Relief Funds; however, the Board of Education votes strictly on the Operating Budget, which is exclusive of the Federal Relief funds.

For FY22, excluding refunding, the District currently projects operating and Federal Relief Act revenues of \$4.041 billion and operating and Federal Relief Act associated expenditures of \$3.807 billion, resulting in an operating surplus of \$234.7 million excluding changes in reserves and an operating surplus of \$198.9 million including changes in reserves<sup>2</sup>. The District projects to end FY22 with a \$401.4 million positive ending fund balance.<sup>3</sup>

Additionally, as detailed further in the Personnel Reports, it is important to note that the District's number of teacher vacancies in the "Vacancy by School" report at the end of the 2021-2022 school year on June 10, 2021 was approximately 208.5 positions. The "Position Summary" report which is as of the end of the fiscal year, June 30, 2022 reflects 853 teacher vacancies as a result of retirements and resignations after the end of the school year. The District's Talent Office has worked since the spring to hire new teachers for the 2022-23 school year.

## **Current Projection versus Amended Budget**

The Current FY22 year-end fund balance projection of \$401.4 million represents a (\$17.7) million decrease relative to the FY22 Amended budget ending fund balance of \$419.1 million. The projected year-end fund balance represents 10.5 percent of expenditures and other uses, or less than six weeks of expense.

## Revenues

As shown in the following table, the net change in operating and Federal Relief Act revenues between the FY22 Amended Budget and the current year-end projection is a deficit of (\$17.4) million:

The primary drivers of this projected (\$17.4) million deficit include:

- A \$14.2 million increase in Local Tax Revenue made up of an \$11.9 million increase in School Income Tax revenue, \$3.1 million increase in Liquor Sales Tax revenue, and \$0.3 million in Business Use and Occupancy Tax revenue from higher than anticipated receipts from the City of Philadelphia; offset by a net reduction of (\$1.1) million in projected Real Estate Tax revenue based on revised estimates from the City of Philadelphia;
- A \$7.7 million increase in Local Non Tax Revenue made up of an unanticipated \$6.4 million in revenue from the Philadelphia Parking Authority and a net \$1.3 million increase in all other Local Non Tax Revenue;
- A (\$13.4) million reduction in State Revenue due to a (\$7.5) million reduction in debt service reimbursement from the State, a (\$5.9) million reduction in the State Special Education Subsidy, and a net increase of \$0.04 million in all other State Revenue;
- A (\$0.08) million reduction in Federal Revenue; and
- A (\$20.8) million reduction in Federal Relief Revenue primarily due to the timing of when Federal Relief Funds will be spent driving a delay in Federal Relief reimbursement; and
- A (\$5.0) million reduction in Other Financing Sources due to a change in anticipated revenues from other funds.

## **Expenditures**

The current year-end expenditure projection is (\$34.6) million lower than the FY22 Amended Budget:

The projected (\$34.6) million variance from the Amended Budget is primarily due to:

- A (\$35.1) million net decrease in District Operated Schools, primarily related to an approx. (\$20.0) million decrease due to the timing of payments and reimbursements funded by Federal Relief Funds which is spread across District Operated Schools, a (\$10.6) million net decrease in Transportation expense, and a (\$4.5) million net reduction in all other District Operated Schools expenditures;
- A (\$0.3) million reduction in Debt Service-related expense;
- A \$5.6 million net increase in Charter School expense due to a \$7.7 million increase in charter school expense due to higher than expected cyber charter enrollment reported at the end of the year, offset by a (\$2.1) million decrease in Charter Transportation;
- A (\$5.1) million net decrease in Other Non-District Operated Schools primarily due to reductions in enrollment and the timing of payments for other out-ofdistrict education programs;
- A (\$4.2) million reduction in Administration expense across all central offices; and
- A \$4.5 million increase in Undistributed Budgetary Adjustments which was budgeted as a credit to offset anticipated reductions and timing delays in schools and offices year-end spending.

## Issues and Risks

Since the school year and fiscal year are now complete, the fourth quarter report reflects more updated and refined projections. However, the District has not finished its closing process so projections will continue to change until the audited financial statements are prepared.

Changes from the Amended Budget are driven primarily by the reduction in Federal Relief Revenue and Expense due to the timing of when Federal Relief Funds will be spent and the associated delay in reimbursement. In addition, since Amended, the District received confirmation that the City's final appeal in the Duffield Case was denied. The Duffield Case was a challenge to the City's Real Estate Assessments process in FY18 and required the District to reimburse certain taxpayers approximately \$35 million.

As noted in prior quarters, the District completed agreements with all of its collective bargaining units and has continued to add additional support for students as they have returned to school, while continuing to reckon with pandemic challenges and continuing violence in the City.

In addition, charter school expenditures continue to grow due to continued growth in cyber charter enrollment.

## Conclusion

The current projections for FY22 reflect the District's best estimate of the impacts of COVID-19 and Federal Relief funding available to date. The District has improved the predictability for its largest expenditure - its workforce - for FY22 and the next few years with the successful negotiation of several labor agreements. At the same time, the challenges caused by the pandemic continue to create uncertainty as the District navigates staffing challenges, evolving protocols, and new supports for students and staff. While this creates a dynamic fiscal challenge for the School District, the significant additional Federal Relief funds allow the District to both navigate the impacts of the pandemic and manage a short-term period of investment. The District has created a framework for how it will approach spending these one-time funds to achieve both learning recovery and identify fiscally sustainable supports for the long-term. 
# FY22 Amended Budget Operating & Federal Relief Fund Budget Summary

## **FY22 Amended Projection**

The District's budget consists of multiple funds: operating, categorical, capital, print, and food services. The current projections, excluding refunding, for the operating budget plus Federal Relief funds includes a \$4.059 billion revenue budget and a \$3.841 billion expenditure budget<sup>4</sup>.


## Operating and Federal Relief Revenues

District revenues are provided by the state, city, federal governments, and other sources.



Approximately 53.2 percent of local revenues are generated from real estate tax. The remaining 46.8 percent of local revenues come from other taxes and fees and a City grant. Approximately 70.6 percent of state revenues are provided through the basic education subsidy. The remaining 29.4 percent of State revenues come from other subsidies and reimbursements. Operating federal revenues and other financing sources make up 0.9 percent of total revenue, but in FY22 there is also \$756.4 million associated with Federal Relief Grant Funds.



## **Expenditures**


The District's FY22 projected budget includes operating and Federal Relief Act expenditures of \$3.841 billion. The District spends 87.9 percent of its budget directly on District, charter, and other non-District schools, with the remainder of the budget expended on debt service (8.2 percent), District administration (3.9 percent), and Other Financing (0.3 percent).



Approximately 56.3 percent of the operating and Federal Relief Fund budget goes to District operated schools (including District administration). Of this amount, 93.1 percent goes to instruction, instructional support and other direct supports to schools. The remaining 6.9 percent is budgeted for District administration.

The remaining 43.7 percent is budgeted for charter schools (32.6 percent), debt service (8.2 percent), other non-District operated schools (2.6 percent), and other financing (0.3 percent).
