Dear West Philadelphia High School Families,

This letter is an update on the West Philadelphia High School basement pipe replacement project.

In November 2016, West Philadelphia High School reported discolored water in some sinks and toilets. As a result, immediate action was taken to identify the source and cause of the discoloration – drinking fountains were immediately shut off, bottled water was provided and lunches were prepared off site. Water testing was conducted throughout weeks of trying to determine the cause and effect.

It has been determined that the water was discolored (yellowish/brown) at times because galvanized basement pipes became rusty. The rust broke apart into small particles showing as discolored water. To correct this problem, the galvanized pipes in the basement were replaced with copper pipes.

There should be no further water discoloration in drinking fountains and sinks. We have flushed all outlets after the new pipe installation and the test results show that the water is safe to drink, in fact testing throughout has shown safe drinking water. All drinking water fountains have been replaced with new filtered hydration stations and filters were installed at an ice maker and kitchen food preparation sinks. Additional water testing was conducted on April 21, 2017 as a quality control measure. The test results showed that the water was safe for drinking. The District will test again in August 2017. Results will be shared on the District's website at <u>www.philasd.org/WPHSwater</u>.

The replacement of pipes and confirmation of test results brings the situation to resolution.
