Dear Constitution High School Families,

This letter is an update on the water at Constitution High School.

In January 2017, Constitution High School reported discolored water in some sinks and toilets. As a result, immediate action was taken to identify the source and cause of the discoloration – drinking fountains were immediately shut off, bottled water was provided. Water testing was conducted to determine the cause and effect.

It has been determined that the water was discolored (yellowish/brown) at times because plumbing components required maintenance, specifically at the strainer before the water meter and related apparatus. To correct this problem, the building manager cleaned the strainer, replaced the the bypass valve, installed a new water pump and took other related remediation steps. A new hydration station was also installed on the third floor.

All necessary steps were taken by the building manager to sufficiently address the discoloration of water. There should be no further water discoloration in drinking fountains and sinks. We have flushed all outlets after the plumbing maintenance work was completed and test results show that the water is safe to drink.
