**4. Question**: Does the SDP have CCTV standards that would apply to this project? If so please provide.

**Answer:** A finish scheme will be developed by the design consultant and submitted to SDP for review and approval during the Design Development phase. Materials shall be cost-effective, durable, easily maintained and sustainable.

**6. Question:** Will the roof replacement contract be completed prior to the commencement of this construction project?

Answer: Yes.

#### <u>General</u>

#### 1. RFP Section 8.0 Phases of Service

Remove the "Reimbursable Services" section in its entirety and replace with the following:

Reimbursable Services:

All reimbursable expenses shall be submitted to SDP for review and approval prior to commencement of the work.

The following investigations are reimbursable services that shall be undertaken in order to confirm existing conditions and scope of work. These investigations shall be

performed during the Schematic Design phase. The design consultant shall retain licensed contractors to conduct each investigation. Contractor proposals shall be submitted to SDP for review and approval prior to commencement of the work. No markup is permitted on contractor fees. At the conclusion of each investigation, reports shall be provided to and reviewed with SDP including recommendations for extent of scope to be included in the Major Renovation project.

- Retain a licensed electrician to survey existing panels, circuitry and breakers to confirm circuitry routing for terminal equipment and remaining capacity of panel boards to serve new and upgraded equipment.
- Retain a qualified contractor to conduct an investigation into the sanitary waste piping using visual investigation and imaging technology to locate damaged piping and quantify the extent of potential failures.
- Retain a qualified contractor to conduct an investigation into the storm drainage piping using visual investigation and imaging technology to locate damaged piping and quantify the extent of potential failures.

Design consultant shall identify and recommend additional investigations requiring contracted services that are necessary for complete and accurate documentation of the scope of work, subject to SDP approval.
