**Question #1:**

Please clarify the language in addendum two that states to include in your base bid the pricing of 6-inch steel and 3-inch copper along with 3-inch pex.

**Response:**

The values indicated on Mechanical Drawing M-001, Bidding Instructions, notes #4 & #5 are estimated lengths of total piping for the entire system for those material types. We expect these values to represent the maximum quantity for these materials and as such do not expect future change order requests for lengths of these materials below the indicated values.

Bidding contractors are individually responsible to perform a full take-off, quantify all materials and calculate associated costs for their respective bid.

**Question #2:**

How many feet of pipe is to be included in the base bid? How many pounds of ductwork should be included? How many feet of wiring should be included?

**Response:**

Quantities of ductwork and control wiring to be used for bidding purposes are indicated on Mechanical Drawing M-001, Bidding Instructions, notes #6 & #7. We expect these values to represent the maximum quantity for these materials and as such do not expect future change order requests for weights/lengths of these materials below the indicated values.

Bidding contractors are individually responsible to perform a full take-off, quantify all materials and calculate associated costs for their respective bid.
