Parent and Family Engagement Policy

In support of strengthening student academic achievement, Lewis Elkin Elementary Schools receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). Section A: JOINTLY DEVELOPED

Elkin will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

- A parent input meeting was held on March 20, 2019 to solicit parent input into the development of the parent and family engagement policy and school parent compact.
- Flyers will be sent home and announcements made through school messenger inviting parents to participate in the School Advisory Council. We will make parents feel welcome and integral parts of the mission and vision.
- Parents will receive regular workshops in academic content areas such as PSSA preparation, Math and Reading Intervention Programs, Parent Portal, Dual Language and other related topics. In addition, parents will receive workshops on the current School Improvement Plan, the school Budget and School Compact in order to create opportunities for parents to be part of the decision-making progress.

- Elkin School will have the Title I Meeting during the month of September 2019. - 2) Elkin staff and administration communicate with parents and families in multiple ways, including: Class Dojo, monthly calendars, message builder via Infinite Campus, parent concern forms, social media, the school website, weekly communication folders, and regular report card conferences and interim reports.
- 3) Assess the needs of parents during regular meetings to schedule additional activities, parent workshops and support groups.
- 4) Parents will be invited to join our SAC, Safe Corridor/Town Watch/School volunteer program
- 5) Parents and the community are encouraged to attend all monthly parent meetings and to participate in the Parent Café.
- 6) Meetings will be held at various times to accommodate parent schedules and will be advertised in advance.
- 7) All communications sent from school will go home in an understandable format in parent-friendly language. Translations into multiple languages can be easily accommodated through the District's Family and Community Engagement office and through Pacific Interpreters.

Section D: SCHOOL-PARENT COMPACT

Elkin Lewis will take the following actions to jointly develop with parents of participating children a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's high standards.

- Parents are encouraged to attend Parent Teacher Report Card Conferences.
- Elkin School will have the Title I Meeting during the month of September 2019. During this meeting, the principal or their designee will give a parent presentation including information on the requirements of Title I part A, parent rights under the law, state academic content standards and assessments, working with educators and how to monitor student progress.
- Elkin hosts, at minimum, a Family Math Night and a Family Literacy Night each year.
- During Back to School Night and during report card conferences, Elkin provides parents/families with information about using interventions (Lexia and iReady), how to view reports on student progress and strategies for using the programs at home.
- Discuss the school plan and budget during the annual Winter Title I meeting.

Section H: BUILDING CAPACITY OF SCHOOL STAFF

Elkin Lewis will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- Parent surveys will be used as an evaluative tool to identify the strengths and weaknesses of the parent involvement program.

The results of these parent surveys will be shared with staff during a PD on effective parent engagement and communication that will take place on one of the district PD days in the Fall or Winter.

Elkin Lewis will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

- Parents are encouraged to attend Teacher-Parent Report Card conferences where parents will discuss their child's progress.
- Our annual Back to School Night, on Thursday, September 19, 2019 from 4:00pm to 6:00pm will also provide information to parents and families about how to work with the school and teachers to monitor student progress.
- Workshops will be offered to provide parents with information to assist them in the use of technology, interpreting assessment data and preparing their children for the PSSA assessment, understanding the State academic content and achievement standards, understanding monitoring student progress and working with their child's teachers.
