Franklin Learning Center Parent and Family Engagement Policy

<u>DESCRIPTION OF HOW THE SCHOOL WILL IMPLEMENT</u> REQUIRED SCHOOL PARENT AND FAMILY ENGAGEMENT POLICY COMPONENTS

Section A: JOINTLY DEVELOPED

Franklin Learning Center will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for

regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

- FLC will hold annually a Spring Title 1 Meeting to review and update the Parent and Family Engagement Policy and the Parent-School Compact. This particular document was reviewed and updated on May 1st, 2018.
- FLC annually hosts a Winter Title I Meeting during which parents are invited to review and provide feedback on the school plan and budget for the subsequent school year.
- FLC will maintain a School Advisory Council.

Franklin Learning Center will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

- FLC will hold its annual Title 1 Meeting during Back to School Night in September.
- Topics to be discussed at the Annual Title I meeting include: Title I requirements and parent rights, the parent documents, schoolwide plan, academic standards, assessments, how to work with educators, how to monitor your child's progress, and curriculum.

Section C: COMMUNICATIONS

- School communication will occur through notices distributed to families via students, Infinite

 staff.
- Many teachers have created websites or use Google Classroom for access to academic material at home.
- FLC will hold parent information and input meetings at varying times of day to accommodate parent/family schedules.
- FLC will provide communications about school functions in English as well as languages indicated by parents for whom English is not their first language, when requested.
- August welcome letter on the website.
- Monthly school calendar.
- Bi-weekly parent-link phone messages.
- Back to School Night.
- When very specific circumstances arise, and family communication must be carried out in a
 language other than English, we have two ready resources. Several teachers and one counselor are
 bilingual. The other ready resource is a telephone instant translation service. This service is
 provided by the School District and is available with a password code, even beyond the hours of the

- regular school day, so that parents can be informed of a student's particular needs, teacher's particular concerns or any other matter of serious import.
- Invite parents and guardians to become members of the School Advisory Council, which will discuss and advise on matters related to school policy, budget and rules.

Section D: SCHOOL-PARENT COMPACT

Franklin Learning Center will take the following actions to jointly develop with parents of participating children a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's high standards.

- In January and March, we will host college awareness and SAT support informational meetings for parents.
- In February, a course selection and data night will be held for all families.
- Invite a parent to sit on the school site-selection committee for the hiring process.

- Report Card conferences are scheduled for two days each report cycle for parents to meet with teachers to discuss student progress

- Technology training for accessing student grades is offered to parents of incoming freshman during Freshman Orientation, September, 2018.
- Technology training for accessing student grades is offered to all parents/guardians during Back to School Night, September, 2018.
- School will provide training around new Infinite Campus system during report card conference so parents can progress monitor their child.
- Counselor will run college-related workshops e.g. FAFSA in the fall

Section H: BUILDING CAPACITY OF SCHOOL STAFF

Franklin Learning Center will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

• FLC will conduct a PD with staff, informed by parent input solicited via surveys, around working effectively with parents.
