PART I. GENERAL EXPECTATIONS

The Albert M. Greenfield Elementary School agrees to implement the following statutory requirements:

- *Parental involvement mandated in School Improvement planning*
 - *Open SAC meeting in the spring to discuss school budget and school plan.*
3. The **School District of Philadelphia** will provide the following necessary coordination, technical assistance, and other support to assist Title I, Part A schools in planning and implementing effective parental involvement activities to improve student academic achievement and school performance:
- In collaboration with the Grants Compliance Monitor, School-Community Liaisons, Philadelphia Home and School Council (PHSC), Title I Parent Advisory Committee, The Philadelphia Right to Know Educational Task Force, PARENT POWER, and other parent groups, provide workshops to schools on parent engagement.
 - Provide professional development by parents/caregivers for new and existing principals and other administrators on how to develop promising partnerships with parents/caregivers.
 - Train new and existing staff with parental engagement duties (e.g., School Improvement Support Liaisons, School-Community Liaisons, School Community Coordinators, and Bilingual Counselor Assistants) to assist school sites in implementing parental engagement.
 - Make available the staff of the Office of Educational Equity, Office of Specialized Instructional Support, and Office of Family and Community Engagement staff for technical assistance.
 - The Grants Compliance/Title I Office will provide technical assistance to schools and parent organizations, such as the Title I Parent Advisory Committee (PAC), Home and School Associations, The Philadelphia Right to Education Task Force, PARENT POWER, and other organized parent groups.
 - Provide coordination of professional development efforts through the Office of Leadership and Development.
 - Provide workshops to parents on supporting student achievement and parent engagement.
4. The ***Albert M. Greenfield Elementary School*** will coordinate and integrate parental involvement strategies in Part A with parental involvement strategies under the following other programs: [Insert programs, such as: Head Start, Reading First, Early Reading First, Even Start, Parents As Teachers, Home Instruction Program for Preschool Youngsters, and State-operated preschool programs], by:
- *Reading As Discovery-Books are sent home several time each week. Books are on students reading level and are an opportunity for students to read at home with their parents.*
 - *Center City School Fair-Allows us to speak with perspective parents about our schools program.*
5. The ***Albert M. Greenfield Elementary School*** will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A programs. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). The school will use the findings of the evaluation about its parental involvement policy and activities to design strategies for more effective

parental involvement, and to revise, if necessary (and with the involvement of parents) its parental involvement policies.

Evaluation will be conducted in a meeting of the Home and School Association and the school administration. Parents will be able to review this policy, comment on it and suggest alterations. Spring 2018.

6. The Albert M. Greenfield Elementary School will build the school's and parents' capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school, parents, and the community to improve student academic achievement, through the following activities specifically described below:

A. The Albert M. Greenfield Elementary School will, with the assistance of the School District, provide assistance to parents, as appropriate, in understanding topics such as the following, by undertaking the actions described in this paragraph --

- the State's academic content standards,
- the State's student academic achievement standards,
- the State and local academic assessments including alternate assessments,
- the requirements of Title I-Part A,
- how to monitor their child's progress, and
- how to work with educators.
- All will be addressed at back to school night on September 26, 2017

Regularly scheduled OPEN HOUSE MEETINGS [fall 2017 and spring 2018] and EVENING MEETINGS [September 26, 2017 as well as monthly coffee and conversation with the Principal will continue to address these and other topics regarding school assessments, programs, special education and legal rights, among others.

B. The Albert M. Greenfield Elementary School will, with the assistance of the School District, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

Regularly scheduled EVENING MEETINGS [September 26, 2017] and Monthly Coffee And Conversation with the Principal [September 2017 thru May 2018] do and will continue to address these and other topics regarding school assessments, programs, special education and legal rights, among others. Family net training will be included in first home and school general meeting in September.

C. The Albert M. Greenfield Elementary School will, with the assistance of the School District, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

Staff development at regularly scheduled intervals throughout the academic year. This will begin with staff orientation September and continue at staff PD on half days and professional development days throughout the year.

- D. The *Albert M. Greenfield Elementary School* will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

Kindergarten interviews

Home and school association offices in the school building

Classroom volunteer opportunities through out the school day

Parent resource table in school lobby

- E. The *Albert M. Greenfield Elementary School* will take the following actions to ensure that information related to the school and parent- programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

Regular bulletins, leaflets, letters and information packets sent home with students or e-mailed. Informational bulletins are sent home for special occasions such as testing programs, interruptions of regular services due to holidays and noon dismissals for staff development or extraordinary circumstances [transit strikes]; assemblies and special programs; advisories. All transmissions are written in English and translated when needed. Some transmissions are sent home at the start of each month with a calendar; others at dates such as Back to School Night Open House [September], report card conferences [December, February and April], standardized testing [per assessment calendar2017-18]; start of school year [September], end of school year [June].

When requested flyers are translated into student home language. Should interpretation services be needed for conferences or other meetings, those services will be arranged in advance


