PART I. GENERAL EXPECTATIONS

 - All will be addressed at back to school night on September 26, 2017

Regularly scheduled OPEN HOUSE MEETINGS [fall 2017 and spring 2018] and EVENING MEETINGS [September 26,2017 as well as monthly coffee and conversation with the Principal will continue to address these and other topics regarding school assessments, programs, special education and legal rights, among others.

- B. The <u>Albert M. Greenfield Elementary School</u> will, with the assistance of the School District, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:
- Regularly scheduled EVENING MEETINGS [September 26, 2017] and Monthly Coffee And Conversation with the Principal [September 2017 thru May 2018] do and will continue to address these and other topics regarding school assessments, programs, special education and legal rights, among others. Family net training will be included in first home and school general meeting in September.
- C. The <u>Albert M. Greenfield Elementary School</u> will, with the assistance of the School District, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

Staff development at regularly scheduled intervals throughout the academic year. This will begin with staff orientation September and continue at staff PD on half days and professional development days throughout the year.

D. The <u>Albert M. Greenfield Elementary School</u> will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

Kindergarten interviews

Home and school association offices in the school building

Classroom volunteer opportunities through out the school day

Parent resource table in school lobby

Regular bulletins, leaflets, letters and information packets sent home with students or e-mailed. Informational bulletins are sent home for special occasions such as testing programs, interruptions of regular services due to holidays and noon dismissals for staff development or extraordinary circumstances [transit strikes]; assemblies and special programs; advisories. All transmissions are written in English and translated when needed. Some transmissions are sent home at the start of each month with a calendar; others at dates such as Back to School Night Open House [September], report card conferences [December, February and April], standardized testing [per assessment calendar2017-18]; start of school year [September], end of school year [June].

When requested flyers are translated into student home language. Should interpretation services be needed for conferences or other meetings, those services will be arranged in advance
