• Parent activities are held at various times during the day to increase parent participation and meet schedule needs.

• Parent training in student Progress monitoring using Infinite Campus will be offered twice annually on an as-needed basis.

Section H: BUILDING CAPACITY OF SCHOOL STAFF

The General Philip Kearny School will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

Staff at Kearny participate in a PD around working effectively with parents during a District PD date in the Fall or Winter. The PD is informed by feedback collected from parents themselves via surveys.

- The school will provide parents and guardians access to information and resources regarding their child's school and serve as a liaison between the parents, community, and District personnel.
