In support of strengthening student academic achievement W.C. Section A: JOINTLY DEVELOPED

We will also provide and send home a copy of the Parent and Family Engagement Policy at that time. Parents will be notified by flyer, monthly calendar and School Messenger. There are three report card conferences throughout the school year, November, February and April, with an evening conference offered each time. During these conferences teachers will discuss with parents how to monitor their child’s progress.
