# **PARENT & FAMILY ENGAGEMENT POLICY**

In support of strengthening student academic achievement, <u>William McKinley Elementary School</u> receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). #### **Section A: JOINTLY DEVELOPED**

In addition, the monthly parent meetings serve as a forum for parents to discuss and evaluate the schoolwide plan, Title I requirements, budgets, student

achievement, and any other pertinent information concerning student achievement and the school.

- The school communicates through the school message system to make reminder phone calls to families.

  - f) Parents will be offered workshops on the Common Core Standards, the School Comprehensive Plan, PSSA/Keystone Assessments and the PASA Assessment for Autistic Support students.
  - g) Parents will be provided with workshops on how to assist their children in developing specific reading behaviors.
  - h) Parents will be updated on their child's progress during parent/teacher conferences, report card conferences, and by accessing Parent Portal.
  - i) Parents will be offered workshops on ways to stay involved.
  - j) Provide workshops to parents on supporting student achievement and parent engagement.
  - k) During McKinley's Back to School Night in September 2021 and the first parent meeting of the school year, parents will be informed of the Title I requirements.

#### Section H: BUILDING CAPACITY OF SCHOOL STAFF

<u>William McKinley Elementary School</u> will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

Professional development will be provided to staff on how to effectively communicate with and include parents in their children's learning. During common planning time, teachers will be provided with strategies to share with parents to support their children's academic & social progress. Teachers are reminded of the need for continuous communication with parents. Teachers maintain Parent Contact Logs and communication is discussed during MTSS meetings. Results of the parent surveys will also be shared with staff in an effort to improve parent communication and engagement.

<u>William McKinley Elementary School</u> will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

School-based staff provide workshops for parents on homework help, literacy, and how to assist their children in developing specific reading behaviors. Information is also shared with our families and the community during Back to School Night and at monthly SAC meetings. We also share information through the SDP's Parent Portal, through our translation services, and by robo calls.
