In order to reduce both the frequency and severity associated with slip, trip and fall (STF) injuries in the workplace, we have to begin with *respect* for the *nature* of this risk. The human being is not designed to constantly and vigilantly think about the risks that might be introduced while they are walking...so let's start there. After this examination, we will consider common workplace hazards to see how detrimental they may be to our employees. As a result, the session leaders will suggest a perspective change on the risks we are accepting in this area. Of equal importance, they will provide practical guidance and resources to help you get started on setting a new "walking safely" standard for your organization. Expect a "same level" falls focus in this one.


