

The Arts Academy at Benjamin Rush Parent and Family Engagement Policy

In support of strengthening student academic achievement, <u>The Arts Academy at Benjamin Rush</u> receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). Section A: JOINTLY DEVELOPED

The Arts Academy at Benjamin Rush will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

Section B: ANNUAL TITLE I MEETING

The Arts Academy at Benjamin Rush will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

- Our Annual Title 1 Meeting will take place during Back to School Night in September. At this time, we will share our Parent Engagement Policy and School Parent Compact and review all information related to Title 1.

SCHOOL/TEACHER RESPONSIBILITIES:

The Arts Academy at Benjamin Rush will:

- Provide high-quality curriculum and instruction including AP Courses, Honors Courses, Blended Learning and Grade Improvement opportunities in a supportive and effective learning environment that enables children to meet the state's student academic standards of achievement.
- Communicate with parents/caregivers regarding student progress regularly via SIS gradebook, phone, email, and during quarterly report card conferences.

- Provide opportunities for parents/caregivers to volunteer in many capacities such as sharing expertise and talent, chaperoning trips, volunteering in the lunchroom, the library, or during special events with proper clearances.
- Enable students to establish and maintain clubs with teacher sponsors and student interest.

PARENT RESPONSIBILITIES:

We, as parents, will:

- Support instruction by encouraging students to be in school every day and scheduling all appointments after school hours.
- Call the school when necessary and refrain from texting or calling a student's cell phone during school operating hours 7:50AM to 2:54PM.
- Become familiar with all class syllabi, the Student Handbook, and The School District of Philadelphia's Student Code of Conduct.
- Check school's website and calendar frequently for information, important documents, and upcoming events.
- Monitor students' extra- curricular activities and their use of social media as outlined in the district Student Code of Conduct.
- Serve on our School Advisory Council, attend Home and School Association / SAC monthly Meetings, and volunteer to assist with at least one event, trip, or performance each year.

STUDENT RESPONSIBILITIES:

We, as students, will:

- Be present, punctual, respectful, and involved in school activities.
- Adhere to dress code and all expectations outlined in the Student Handbook.
- Utilize technology and social media responsibly.
- Demonstrate academic integrity and honesty.
- Act in a civil manner that respects the school and social environment as outlined in the Student Handbook and in the School District of Philadelphia's Student Code of Conduct.

- Communicate in a careful and respectful manner with teachers, peers, and all members of the school community.
- Demonstrate our commitment to our education by completing all school assignments on time, to the best of our ability, with attention to quality.
- Provide all notices and information distributed at school to parents/caregivers.
- Respect the various views of our diverse student population.

Section E: RESERVATION OF FUNDS

The Arts Academy at Benjamin Rush will take the following actions to involve the parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parent and family engagement is spent by:

- How funds for parent and family engagement will be spent will be determined by all stakeholders during the Spring SAC meeting.
- Parents will also be invited to a Title I Parental Input Meeting in the winter to discuss the school budget and how best to use those funds for their child's education.

- Parents will be provided training on obtaining clearances and use of the parent portal.
- Counselor will hold various workshops in response to parental requests
- Parents will be provided training on FAFSA
- A computer is available for Parent use in the main office
- A monthly newsletter on parenting will be provided to all families
- All parents receive syllabi that outline the standards, resources, and grading policies for all courses for their children
- All parents will receive interim reports prior to each report card distribution

Section H: BUILDING CAPACITY OF SCHOOL STAFF

The Arts Academy at Benjamin Rush will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- Working with staff to review appropriate and effective parental contact via staff development meetings.
- Ensuring that teachers, counselor, nurse, and other essential staff members make regular phone calls home regarding student progress, behavior, attendance, and / or achievement.
- Ensuring that all staff are trained to be culturally sensitive.
- Ensuring regular collaboration between parents/caregivers during monthly staff at SAC meetings and Home and School meetings.
- Utilizing parent survey data to inform all decision making.

The Arts Academy at Benjamin Rush will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by contacting the Main Office.

PARENT AND FAMILY ENGAGEMENT POLICY DISCRETIONARY COMPONENTS

- Enabling parents / caregivers to participate in phone conferences regarding the progress of their children if work prevents them from attending meetings.
- Encouraging parents to partner with teachers in the arts as well as academics for the purpose of implementing events, performances, and extracurricular activities.
- Encouraging all parents to obtain necessary clearances for volunteering.
