## THE SCHOOL DISTRICT OF PHILADELPHIA MEETING OF THE SCHOOL REFORM COMMISSION

#### AUGUST 22, 2013

A meeting was held by the School Reform Commission on August 22, 2013 in the Auditorium of the School District of Philadelphia Education Center, 440 North Broad Street.

The meeting was convened at 5:30 p.m. by Dr. Wendell Pritchett.

**Members present:** Ms. Houstoun, Dr. Pritchett, Ms. Simms – 3

Members absent: Mr. Dworetzky, Mr. Ramos – 2

Michael A. Davis, General Counsel, announced that prior to today's public meeting, the School Reform Commission met in Executive Sessions on August 19, 2013 to discuss labor relations and personnel matters and today, to discuss labor relations, litigation, and investigations.

The minutes from the following School Reform Commission meetings were approved: April 18, 2013, May 30, 2013, May 30, 2013 (*Intermediate Unit*), June 19, 2013, June 19, 2013 (*Intermediate Unit*), June 27, 2013, and July 2, 2013

Evelyn Sample-Oates, Office of Family and Community Engagement, provided the order of business for today's meeting of the School Reform Commission. She also stated that the proceedings of today's School Reform Commission meeting are being broadcast live on television and streamed live on the internet. Ms. Sample-Oates stated that the School District's recordings are protected by the copyright laws of the United States.

Dr. Hite, Superintendent, provided opening remarks. He provided an update/overview of the school registration process. He stated that the first day of school is Monday, September 9, 2013. Dr. Hite stated that the District has continued to focus on safety of all students and quality of school environments and will be presenting a revised Student Code of Conduct and revised policies on bullying and harassment.

The meeting was opened to the public for presentation of statements.

Amy Chen, junior at Science Leadership Academy, expressed concerns about the quality of education. She stated that \$50 million requested is not enough to open schools.

Danita Bates, Community Activist, stated that the \$50 million requested is not enough. She stated that the District should ask for what is needed, as the District is not fully funded. She also questioned when does the District plan to announce the next 33 school closures.

Karel Kilimnik, retired teacher and member of the Alliance for Philadelphia Public Schools, questioned the Broad Superintendents Academy. She also questioned who is paying for the new Renaissance Charter Schools. Dr. Hite stated that they are being funded by a federal school improvement grant and funds raised by the schools.

Rich Migliore stated that he wants children to have equal opportunity to the education that they deserve. He stated that he wants collaborative, open and inclusive leadership and governance. Mr. Migliore stated that he wants all schools to be fully funded equally with small class sizes, all necessary support staff, including nurses, counselors, arts and humanities, and reading specialists.

Phillip Aiken, parent, questioned where is the passion for education.

Lisa Haver, member of the Philadelphia Alliance for Public Schools, questioned the School Reform Commission, under Chairman Ramos, unanimous vote to take away longstanding workers' rights. Ms. Haver also questioned the relationship between Trujillo, Rodriquez and Richards and the State. She stated that she plans to file a Right to Know request with the State's Office of Open Records.

Vercil Dublin-Stone, parent, presented a statement on behalf of her son's proposed expulsion (SRC-5).

Helen Gym, Parents United for Public Education, expressed concerns about parents not knowing what to expect on the first day of school. She expressed concerns about split grade classrooms. Ms. Gym also expressed concerns about the lack of guidance counselors and reductions in nurses and librarians.

Toni McIlWaine, Touch of Heaven Outreach, stated that a new structure is needed, as the current structure is not working.

Orlando Acosta, Community Activist, stated that \$50 million is not enough to open schools. He suggested that students and teachers not show up for school.

Alison McDowell, Masterman parent, questioned to whom the District is accountable. She also rejected the School Report Card.

Vivian Hughes, volunteer aide at Mifflin School, requested the return of a staff member.

Cecilia Thompson, parent, posed a series of questions: what are Learning Networks; Transportation Update; suggested the elimination of the uniform policy; requested more information on resolution B-7. Ms. Thompson, citing resolutions B-3 and B-25, expressed concerns about schools' ability to raise funds. She also expressed concerns about the timing of ESY services ending and the start of school.

Dr. Jeanne Robinson, retired social worker, psychologist and family therapist, and educator, expressed disappointment in the public school system. She suggested rehiring the experienced teachers first and reconsider the methodology for development of charter schools.

Maureen Fratantoni, President of the Home and School Association at Nebinger Elementary School, requested the return of a lost music teacher. She also stated that there needs to be better communication from the District to parents, community and partners.

Robin Dominick, President of the Home and School Association at Powell Elementary School, expressed concerns about proposed split classes and overcrowding at Powell Elementary School.

John Culhane, parent, expressed concerns about the loss of personnel at Powell Elementary School.

Joan Taylor, teacher at Middle Years Alternative, expressed concerns about schools "self funding", stating that it is not an equitable system.

David Hensel, teacher, expressed displeasure with public school teachers apparently being blamed for the School District's budget crisis.

Greg Brinkley, Abbottsford Homes Tenant Council, expressed concerns about the apparent forced transfer of personnel at Mifflin Elementary School.

Harold Sheppard expressed concerns about Camelot apparently obtaining Germantown High School.

Dr. Hite responded to speaker questions and inquiries. Regarding Renaissance Charters, Dr. Hite stated that first year funding is from a U.S. Department of Education school improvement grant and funds raised by the providers. Cuts in subsequent years will be borne by the School District. Regarding Learning Networks, Dr. Hite stated that they are a number of schools geographically organized and managed by eight Assistant Superintendents. With regard to parental expectations for the first day of school, Dr. Hite stated that information will be posted on the School District's website. With regard to school uniforms, Dr. Hite stated that it is the expectation that no principal is able to turn a student away because their uniform is incomplete. In response to speaker Harold Sheppard who stated that there is no music or sports at M. L. King High School, Dr. Hite stated that he had visited the school two days ago and watched students in football practice. He stated that he observed student leaders with a purpose of being successful. In response to questions regarding transportation, Fran Burns, Chief Operating Officer, provided an update. She stated that 349 routes are covered by the School District and 800 routes covered by private contractors. She stated that in order to meet staffing needs, the District rescinded 50 scheduled layoffs. Ms. Burns stated that the District will provide average drive times in mid-September. She also stated that there will be a call center to take calls. With regard to concerns raised about split classes at Powell Elementary School, Dr. Hite stated that the School District will be able to bring back some counselors, assistant principals and teachers. He stated that split classes will be addressed at the earliest grades first.

Vare Middle School, 2100 S. 24th St., Philadelphia, PA 19145 as an authorized charter facilities location for UICS, for a term commencing on August 23, 2013 through June 30, 2016, which shall terminate in the event that the Universal Vare Promise Neighborhood Partnership Charter School charter or the UICS charter is nonrenewed or revoked; and be it

RESOLVED, that the School Reform Commission in its capacity as Board of Directors of the Philadelphia Intermediate Unit No. 26(IU 26), hereby authorizes IU 26, through the acting Executive Director or his designee, to execute, deliver and perform subgrant agreements with eligible charter schools, to supplement the provision of special education and related services for students with disabilities attending these charter schools, for an amount for each charter school not to exceed the amounts allocated by the Pennsylvania Department of Education, under IDEA, Part B, for an aggregate amount not to exceed \$10,300,000, for the period commencing August 22, 2013 through June 30, 2014:
