**Section A: JOINTLY DEVELOPED**

South Philadelphia High School will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

***Parents are encouraged to attend the Annual Title I Spring meeting to review and give input into this document, as well as the Compact. This year's meeting took place on May 12, 2020. Parents were notified of this meeting through flyers and monthly calendars sent home with students as well as a phone blast. The Policy and Compact will be updated annually with input from the Title I Spring Parent Meeting.***

***We will hold an Annual Title I meeting on Back to School Night in September 2020 where we will invite all parents to participate. We will also provide and send home a copy of the Parent and Family Engagement Policy at that time. Parents will be notified by flyer, monthly calendar and school messenger.***

Parents are notified about various meetings, assemblies and events during the school year through flyers and monthly calendars sent home with students as well as through school messenger. Meetings, trainings and workshops are held at various times of the day to accommodate all families and their schedules. All communications sent home are in the family home language. ## **Section E: RESERVATION OF FUNDS**

***Each Winter, parents are encouraged to attend a budget review meeting. At this time, parents can give input into how they would like to see the 1 percent of parent involvement funds to be spent. Parent Involvement funds are used towards the purchase of a School Improvement Support Liaison (SISL). One of the duties of the SISL is to support and increase parent engagement by holding parent meetings, sending out phone blasts and working with families to set them up with organizations for any resources needed. This year's meeting was held on January 23, 2020.***

## **Section F: COORDINATION OF SERVICES**

South Philadelphia High School will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children by:

***Southern HS has over 20 community partnerships: WES, The Philadelphia Dance Foundation, The Future Project, Health Resource Center, City Life Church, Inner Strength, Jefferson University, Viet Lead, Sunrise, Teen Elect, Bethanna, DHS Liaison, Migrant Ed, Mural Arts, United Communities SE Phila, LOMO and the Curtis Institute. These organizations offer students and families resources such as Mental/behavioral health services, job opportunities, and after school leadership empowerment series to name a few.***

## **Section G: BUILDING CAPACITY OF PARENTS**

South Philadelphia High School will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

1. Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and
2. Materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement
3. Providing assistance to parents of participating children, as appropriate, in understanding topics such as the following:

- a) The challenging State’s academic standards
- b) The State and local academic assessments including alternate assessments
- c) The requirements of Title I, Part A

- e) How to work with educators to improve the achievement of their child

***Various workshops and trainings are offered to parents throughout the school year. Some of the topics being covered are Math Night, Literacy Night, and Principal & Parent Chat-N-Chews. We will hold an Annual Title I meeting on Back to School Night in September 2020 where we will invite all parents to participate. During this meeting, we will inform them about the Title I program, requirements of Title I Part A, parent rights under Title I, the state academic content standards and assessments (Keystones), how to work with educators, strategies for monitoring student progress and information about the school curriculum and graduation requirements. There are three report card conferences throughout the school year, November, February and April, with an evening conference offered each time. During these conferences teachers will discuss with parents how to monitor their child’s progress.***

**Section H: BUILDING CAPACITY OF SCHOOL STAFF**

**South Philadelphia High School** will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

***Surveys are made available to parents during all events, meetings and conferences. The results of the parent surveys are tallied and shared with staff during Professional developments throughout the school year. In August, staff will be trained on how to communicate and work with parents as equal partners.***
