Section A: JOINTLY DEVELOPED

<u>The Spring Garden School</u> will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

At the request of parents and families, Spring Garden will continue to offer a resource fair in the Gym to invite parents to learn more about the resources available to them in the community.

Regular bulletins, leaflets, letters, and information packets will be sent home in the "Parent Communication Folder." All transmissions are written in English and translated when needed. When requested, flyers will be translated and sent home in the student's home language. Should interpretation services be needed for conferences or meetings, those services will be arranged. Communications are also posted in and around the office. Robo-calls are used as necessary. All teachers and parents are expected to set up Classroom Dojo as a means of establishing regular communication. Communication is shared in

parent friendly language. Meetings and workshops will be held at various times during the day and evenings.

Section F: COORDINATION OF SERVICES

- Kindergarten registration will be advertised by hosting a Kindergarten open house for parents and prospective students. Parent and child will be invited to visit the kindergarten classrooms and learn about the program. A checklist of expectations is given to parents.
- The Parent Resource Center is located in suite 104, across from the main office. This location was selected to provide parent's access to the school counselor and our other support service providers including the speech therapist and school psychologist. This area will serve as a primary meeting space for MTSS, treatment team, and IEP meetings. Located outside of the Parent Resource Center is a display stand where parents can find a variety of information on programs and services as well as extra copies of the monthly calendar and parent newsletters.

Section G: BUILDING CAPACITY OF PARENTS

The Spring Garden School will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

1. Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and

- 2. Materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement
- 3. Providing assistance to parents of participating children, as appropriate, in understanding topics such as the following:

Topics a) through e), as well as an explanation about the curriculum used by Spring Garden School are reviewed during the Annual Title I meeting held during Back to School Night. All teachers provide a syllabus to parents that includes information about monitoring their child's progress, communicating with instructors, classroom rules, etc.

• Spring Garden School will hold academic workshops each quarter to provide parents with instructional information to support their child. Topics may include school assessments, PSSA, interventions, Parent Portal/Infinite Campus training, special education, literacy, and math, among others. Spring Garden School will share online training opportunities for parents and families, as well as stepper sheets where appropriate.

Section H: BUILDING CAPACITY OF SCHOOL STAFF

<u>The Spring Garden School</u> will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

• Staff at Spring Garden School participate in a PD around working effectively with parents during a PD date in the Fall/Winter. The PD is informed by feedback collected from parents themselves via surveys.

<u>The Spring Garden School</u> will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

- Planning meetings between Office of Mutli-Lingual Curriculum and Programs and parent representative as needed
- The school will provide parents and guardians with access to information and resources regarding their child's school and serve as a liaison between the parents, community, and District personnel.
