Section A: JOINTLY DEVELOPED

- Steel's STEP team coordinates monthly Parent/Family events to connect families to resources and community organizations, ranging from healthy lifestyle, dealing with trauma, by the needs of our families.
- Steel Community Relations Liaison collaborates with families to identify barriers to student achievement and success and works in coordination with school staff/partners to alleviate these barriers.

Section G: BUILDING CAPACITY OF PARENTS

Edward T. Steel School will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- Training will be offered for parents on Literacy and Technology and other informational sessions.
- Teacher-Parent Conferences allow for parents to discuss their child's academic progress and ask any questions.

Edward T.
